The Food Access Coordinator is responsible for overseeing and executing outreach and/or market operations related to Texas Farmers' Market food access programming for the Double Dollar Incentive Program (DDIP), SNAP and FMNP eligible families and individuals. The position requires personal skills, organization, and ability to multitask.

- Must be able to work onsite at a rain or shine market

## **Major Responsibilities:**

- Help customers use their SNAP and WIC vouchers and cards to make purchases.
- Distribute matching benefits in the form of paper scrip which can then be redeemed for fruits and vegetables.
- Track the DDIP program by asking brief questions of customers and entering their responses into a

- laptop on site.
- Distribute general information about the markets and assist volunteers with terminal and merchandise sales.
- Troubleshoot and problem solve issues at market as they arise
- Monitor market supplies and equipment inventory and report supply needs to Operations Manager
- Complete and file market paperwork to Operations Manager at the end of each market
- Provide feedback to the operations team to adapt and improve market operations and procedures
